### Interstate I-81 Project

NYSDOT has released the Draft Environmental Impact Statement (DEIS) for the Interstate 81 Viaduct Project. SHA has a copy of the DEIS and you can view it by calling 315-470-4240. You may also view it online at <https://www.dot.ny.gov/i81opportunities>.

#### What is the I-81 Project?

*The project will **remove** the existing elevated aging and now obsolete I-81 Viaduct that divides the City of Syracuse and replace it with an **integrated Community Grid** that will disburse traffic along local north-south streets, create a new business loop, and reconnect the neighborhoods severed by the interstate.*

#### When will the project start?

*The project is tentatively scheduled to break ground in 2022. Preliminary plans call for construction in 5 phases.*

#### When will construction be on the section of the I-81 viaduct near Pioneer Homes?

*Tentatively scheduled for the **Spring of 2023***

#### Are Pioneer Homes residents being forced to move during construction? **NO**

*NYSDOT spokesman Joe Morrissey stated that “NYSDOT is **not forcing** residents of **Pioneer Homes** to move. There are no plans to temporarily displace people living in Pioneer Homes as part of the construction project. NYSDOT is working directly with SHA and the community to mitigate impacts as they relate to the project.”*
